WEDDING QUALIFYING CONNECTIONS TO THE PARISH

A person has a Qualifying Connection with a parish if: **that person:**

Code	Reason
1	was baptised in the parish. (This does not apply where the baptism formed part of a combined service of baptism or confirmation); or
2	had his or her confirmation entered in a church register book of a church or chapel in the parish; or
3	has at any time had his or her usual place of residence in the parish for at least 6 months; or
4	has at any time habitually attended public worship in the parish for at least 6 months.

or if a Parent of that person has at any time during that person's lifetime:

Code	Reason
5	had his or her usual place of residence in the parish for at least 6 months; or
6	habitually attended public worship in the parish for at least 6 months.

or a Parent or Grandparent of that person was married in the parish.

In all cases involving church services - i.e., coming to/going to/attending normal church services, baptism, confirmation, or marriage - this applies only to Church of England services.

IF YOU DO NOT HAVE A QUALIFYING CONNECTION WITH CRONDALL & EWSHOT PARISH

Code 7

- You are legally obliged to make one by attending services in the parish over a six-month period or more.
- As we need to prove that couples who do not have a connection by living in the parish have made that connection by attending services over a six-month period or more, we have put a book at the back of both St Mary's and All Saints
- **Couples MUST sign each time you come to a service so we can prove that the necessary connection has been made.** This is a legal requirement, so we wouldn't want to have any trouble proving that connection.
